

ATHLETIC ELIGIBILITY CHECKLIST

ALL ATHLETES & PARENTS/GAURDIANS SHOULD REVIEW THEIR ATHLETIC PACKETS TO ENSURE ALL FORMS HAVE BEEN COMPLETED AND SIGNED PRIOR TO SUBMITTING THEM TO THE ATHLETIC DIRECTOR.

ATHLETES & PARENTS/GAURDIANS:

_____ **STEP 1: PURCHASE AN ATHLETIC PACKET FROM THE SCHOOL BANK.**

_____ **STEP 2: OBTAIN AN ATHLETIC PHYSICAL FROM A DOCTOR.**

_____ **STEP 3: REVIEW THE PACKET TO ENSURE ALL FORMS HAVE BEEN COMPLETED AND SIGNED.**

_____ **STEP 4: VERIFY THAT THE STUDENT IS ACADEMICALLY ELIGIBLE.**

- STUDENTS MUST HAVE EARNED TWO (2) CREDITS THE PREVIOUS SEMESTER WHICH EQUALS 4 CLASSES
- STUDENTS MUST HAVE EARNED A 2.0 GRADE POINT THE PREVIOUS SEMESTER
- TRANSCRIPTS MUST BE VERIFIED FOR OUT OF STATE STUDENTS

_____ **STEP 5: VERIFY WHAT SCHOOL THE STUDENT ATTENDED LAST YEAR.**

- RETURNING STUDENTS SHOULD MEET APPROVAL.
- STUDENTS WHO PREVIOUSLY ATTENDED A FEEDER SCHOOL SHOULD MEET APPROVAL.
- STUDENTS WHO PREVIOUSLY ATTENDED ANOTHER HIGH SCHOOL OR A FEEDER SCHOOL IN ANOTHER ATTENDANCE ZONE MUST HAVE MOVED OR RECEIVED A ZONE VARIANCE & MUST FILL OUT A TRANSFER OF ELIGIBILITY FORM.

_____ **STEP 6: IF THE STUDENT IS ON A ZONE VARIANCE, RESIDENTIAL AFFIDAVIT, TEMPORARY GUARDIANSHIP, OR A FIFTH YEAR SENIOR:**

- STUDENTS ON A ZONE VARIANCE.
 - STUDENTS WHO ATTENDED THE PREVIOUS YEAR ON A ZONE VARIANCE ARE APPROVED BASED ON A CONTINUED ENROLLMENT.
 - STUDENTS ON NEW ZONE VARIANCES ARE INELIGIBLE FOR 180 SCHOOL DAYS AND MUST COMPLETE A TRANSFER ELIGIBILITY FORM (TEF) AND A SUB-VARSITY NIAA APPEAL OR
 - A LETTER OF APPEAL FROM THE ATHLETIC DIRECTOR.(FOR STUDENTS WHO ATTENDED GVHS THE PREVIOUS YEAR)
- STUDENTS ENROLLED AS FIFTH YEAR SENIORS OR ON A TEMPORARY GUARDIANSHIP OR A RESIDENTIAL AFFIDAVIT ARE INELIGIBLE AND MUST REQUEST APPROVAL BASED ON A HARDSHIP.
